

SMPTE Winter Television Conference

The dates for the Winter TV Conference have been set—January 17 and 18, 1969, according to Program Chairman **Harold Wright**, Canadian Broadcasting Corp., Toronto, Ontario, Canada. The Conference will be held in the Ryerson Polytechnical Institute Theatre, 50 Gould St., Toronto. Arrangements Chairman **Harold Eady**, Bonded TV Film Service, 15 St. Mary St., Toronto, has reserved a group of rooms for SMPTE registrants at the nearby Westbury Hotel until January 1, 1969. Hotel information and reservation forms will be mailed out to members, along with a pamphlet on the ease of crossing the Canadian border and airline information.

The theme of this television workshop is "An Integrated Systems Approach to Color Television Broadcasting." The Conference hopes to cover network color vs. local color; color variations within a single source; effects of different demodulators; electron video recording; color remote facilities; and refinements of colorimetry equipment. The Conference will be confined to broadcast problems.
