### 1. REFERENCES TO GENDER

#### **Constitution and Bylaws**

*Amended to remove all references to gender. (The amended Constitution and Bylaws appear in the Annual Directory for Members, published April 1989.)*

### 2. REGIONAL REPRESENTATION

#### **Bylaws, Article III, Section 2, Subsection B**

*Amended to read:* Each region shall be represented on the basis of one Governor for each 500 members, or fraction thereof, of any grade. No one section within a region shall have more than one Governor for each 500 Section members or fraction thereof, of any grade except by two-thirds vote of the Board of Governors. Governors representing regions in the United States and Canada shall be elected by the voting membership in their respective regions. International Governors shall be elected as specified in Article III, Sec. 6, below.
